Santé en français also intends to take a more active role in evidence collection and analysis, consulting with patients/users about their challenges and collaborating with service providers who are already gathering data.

Santé en français works to make health and social services accessible to the French-speaking community. The organization aims to take a more active role in decision-making by influencing provincial decision-making bodies, which can only be achieved through a stronger presence and enduring relationships with various departments. Santé en français also seeks to leverage intergovernmental relations to address certain cross-sectoral French-language health issues. The organization is committed to influencing provincial policies to protect the rights and interests of Manitoba's French-language health care system.

Since 2004, the government has recognized Santé en français as the francophone community's spokesperson for health and social services, a role that is also acknowledged and supported by our community partners. As the voice of the Franco-Manitoban community, Santé en français ensures the government hears the community's concerns regarding health and social services. The organization strives to strengthen the defence and protection of access to quality health and social services in French. This provincial role requires increased collaboration with all service providers across the province.

Additionally, Santé en français aims to enhance system performance by offering innovative solutions to key systemic challenges, in collaboration with the government and service providers. These solutions address issues such as complaint management, foreign qualification recognition, and health system navigation.
